Dear All Homeowners:

Due to the severe nature of salt air, wind and sun, our condo building paint has deteriorated to the point that some window ledges have water leaks and it has affected some rebar holding the ledges in place. Most (if not all) of you should notice cracks and layers of missing paint by your windows.

Luckily we have been putting enough money into our paint reserves to cover the cost of pressure washing old paint off, leveling the areas where multiple areas of paint have been washed or peeled off and painting of the entire building, patios walls and the wood trim on the parking areas,

The board has looked at several other condos and decided on grays and blues being up to date and appealing to the eye, which should help us increase the value of our units.

We have painted the sample colors on the west facing side of the building around unit 103. The main parts of the building will be a light gray (Sherwin Williams - Agreeable Grayhttps://www.sherwin-williams.com/homeowners/color/find-and-explore-colors/paint-colors-by-fa mily/SW7029-agreeable-gray).

The bump outs and elevator tower will be a shade of blue (Sherwin Williams - Labradorite <u>https://www.sherwin-williams.com/homeowners/color/find-and-explore-colors/paint-colors-by-fa</u> <u>mily/SW7619-labradorite</u>). The painting of the bump outs in a different shade than the rest of the building is similar in style to the existing painting scheme.


VOTING BY PROXY

- 3. By selecting "General Powers" on the Proxy, you authorize and instruct your proxy holder to use his/her best judgement on all matters which properly come before the meeting and for which a general power may be used.
- 4. By selecting "Limited Powers", your proxy holder may only cast your vote as you specifically direct. For your vote to be counted on that issue, you must indicate "yes" or "no" on the question on the proxy.
- 5. The proxy should be submitted to the Association prior to the scheduled time of the meeting.
